Annual Out of Pocket Cost (up to age 19): Your total out-of-pocket costs for Benefits from Delta Dental Premier Providers will not exceed \$375 per Coverage Year for each Covered Person (under the age of 19) with an out-of-pocket of \$750 per Coverage Year for two or more Covered Persons (under the age of 19) receiving Benefits under this Policy. Only deductibles and coinsurance which the Covered Person is responsible to pay will count toward the out-of-pocket cost. Other than deductibles and coinsurance, dollars necessary to be paid by the Covered Person for Optional Procedures as further defined do not satisfy out-of-pocket costs.

<u>Annual Maximum Benefit (age 19 and up)</u>: \$1,000 per person per coverage year. All services are subject to the annual maximum benefit and will not be paid if your annual maximum benefit has been reached. Adult dependent children are covered to the end of the year age 26 is attained.
